1. What is this product about?

This product covers loss of or damage to property whilst within the business premises against the risks of Burglary or Housebreaking following forcible and violent entry or exit, damage to the premises resulting from such Burglary or Housebreaking or attempt thereat, or Property temporarily removed from the insured premises, provided the Company's prior approval is obtained in writing.

2. What are the coverage and exclusions provided?

The policy covers:

Furniture, fixtures, fittings, office equipment, goods held in trust or on commission for which the insured is responsible, insured's own stock-in-trade, tools utensils, spare parts, household goods and personal effects. The property insured is only covered whilst in the premises of the insured as specified in the policy. If more than one location is involved, a separate sum insured must be declared in respect of each location and premium must be charged accordingly.

The insured property can either be insured on a Full Value or First Loss Basis:

1. Full Value Basis

This basis is adopted when there exists a possibility of your entire property insured being stolen at any one time. You must answer the questions fully and accurately.
- b. Failure to take reasonable care in answering the questions may result in avoidance of your contract of Insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of Insurance.
- c. The above duty of disclosure shall continue until the time your contract of Insurance is entered into, varied or renewed with us.
- d. In addition to answering the questions in the Application Form (or when you apply for this Insurance), you are required to disclose any other matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied.
